This inverted graph tells the story of how the number of customers who chose not to renew their service decreased—in other words, customer base stabilized.

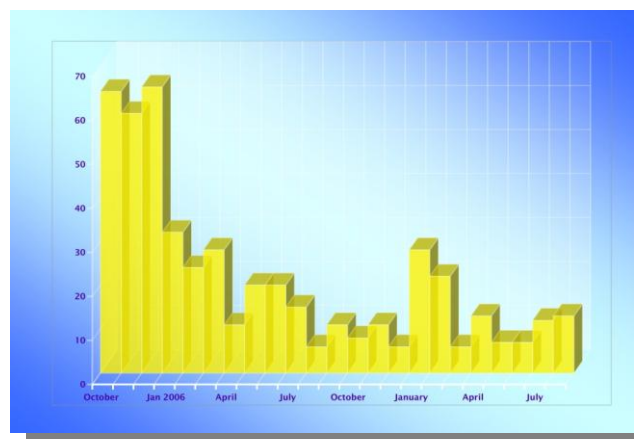


Total Revenue
